TERMS AND CONDITIONS

SUBMIT SEPARATE TENDER FORM EACH FOR BUS, MINIBUS, JEEP

1. The tender form duly completed and signed along with EMD in the form of DD or cash receipt and PAN Card should be sealed in **Envelope A**. Price Schedule should be sealed in **Envelope B** and both Envelope A and Envelope B should be packed and sealed in another envelope bigger enough to contain both the envelopes.
2. Only sealed Tender will be accepted in prescribed form.
3. The Tender is non ó transferable.
4. No tender shall be considered if the contents are erased, illegible or overwritten. Any corrections should be scored and rewritten under the initials for the Tenderer. As far as possible tender should be without any corrections.
5. The tender will be opened on **29/5/2018 at 15:00 hrs in the Conference Hall of Nagpur Veterinary College, Nagpur Dist - Nagpur** in the presence of Bidderø representative who choose to attend at the time, date and place specified in the schedule of requirements. Change in the place of opening of tender, if any, will be communicated in advance. If required, at the time of opening the tender the Associate Dean or Tender Opening Committee can ask for specific documents which will have to be provided at that time.
6. Each tender should be accompanied by **earnest money deposit of Rs. 3000/-** in term of Cash/Demand Draft of Nationalized bank. This Earnest Money will be accepted in Demand Draft in the name of the **“Pay & Account Officer, MAFSU, Nagpur Veterinary College, and Nagpur Payable at Nagpur”**. No tender will be considered without earnest money deposit. Conditional tender will not be accepted.
7. The Earnest Money deposited by the Tenderer shall remain in the safe custody of the Associate Dean, Nagpur Veterinary College, Nagpur, until the acceptance of the tender is made known to the Tenderer.
8. Any infringement of the terms and conditions will make the Tenderer liable for cancellation and further any earnest money or security deposit paid will be forfeited by the Associate Dean, Nagpur Veterinary College, Nagpur.
9. Tenderer will not be allowed to withdraw his tender after opening the same without forfeiting his earnest money deposited.
10. The tender will be awarded to the bidder quoting highest cost for bus/minibus/jeep

11. The material will be handed over to the bidder to whom tender is awarded only after the receipt of total amount quoted in his tender.
12. The bidder to whom tender is awarded shall deposit the amount quoted in his tender within 5 day, failing which, the earnest money deposit shall be forfeited.
13. The college vehicles to be sold out through this tender may be inspected during the office hours between **8/5/2018 to 28/5/2018** before filing the tender. No complaints shall be entertained in this regard, once the tender is awarded.
14. The Tenderer to whom the tender is awarded shall have to lift the material from the place at which it is available in the college premises.
15. No complaints shall be entertained once the amount is deposited and material is handed over to the successful bidder.
16. The RTO, Nagpur office has recommended the bus and minibus to be sold out through this tender as non usable and for cancellation of registration and also to be scrapped. Hence the successful bidder shall certify in this regard and also deposit the chassis plate of this bus to the office of Associate Dean, Nagpur Veterinary College, Nagpur.
- 17. The Tenderer shall necessarily have pan card and copy of the same shall be attached with this tender form.**
18. It is within the discretion of the concerned college authorities to relax the conditions in exceptional circumstances.
- 19. The Associate Dean, Nagpur Veterinary College, Nagpur reserves the right to accept or reject any or all the tenders without assigning any reason thereof.**
